## March 2023 Review

### Notable Mergers & Acquisitions and Asset Transactions

#### MERGER & ACQUISITIONS

- American Electric Power agreed to sell its 1.3GW of unregulated renewable energy portfolio to IRG Acquisition Holdings for an enterprise value of approximately \$1.5 billion including project debt. The portfolio comprises 14 projects, constituting 156MW of solar PV and 1.2GW of wind assets across the US
- Fiera Infrastructure and Palisade Infrastructure Group agreed to acquire a 100% stake in Amp US Primary Holdings. Amp US develops and operates community solar and storage projects and currently has a portfolio of 39 projects across the US with a combined capacity of 200MWdc. Financial details of the transaction were not disclosed
- Denham Capital acquired C&I solar developer Solops for \$200 million. Solops has deployed over 3GW of solar PV capacity across 19 US states including some community solar projects that serve lower-income communities

#### ASSET TRANSACTIONS

- Repsol acquired 250MW of wind and solar development assets from ABO Wind in Spain. The portfolio comprises 3 wind farms totalling 150MW and 2 solar PV projects with a combined capacity of 100MW
- EDF Renewables acquired 17 development-stage solar projects with a combined capacity of 529MW from MEC Group in Germany. The projects are expected to reach the RTB stage in 2024 and 2025
- Altus Power, Inc. closed the acquisition of approximately 220MW of solar assets, including 207MW of operating assets and 13MW of assets under construction from True Green Capital Fund III, L.P. for \$293 million
- SOWITEC sold 3 solar PV plants with a combined capacity of 570MW to an undisclosed major international utility in Mexico. The PV plants are expected to start commercial operations in 2025
- TotalEnergies agreed to sell a 50% stake in its 234MW renewable project portfolio to Crédit Agricole Assurances for an enterprise value of \$300 million. The portfolio comprises 23 solar power plants with a combined capacity of 168MW plus 6 wind farms with a total capacity of 67MW

### Notable Fund Raisings & Project Finance Transactions

#### FUND RAISINGS

- NextEnergy Capital reached the third close of its NextPower UK ESG fund at £595 million, exceeding its initial target size of £500 million. The fund will focus on investments in unsubsidised new-build utility-scale solar projects with PPA in the UK. The third close was reached with commitments from existing investors Border to Coast Pensions Partnership and UKIB

#### FINANCING RELATED

- Voltalia SA secured \$268 million in syndicated debt financing. The financial package was provided by BNP Paribas, CACIB, Natixis, Arkea, Pireaus, La Banque Postale, CIC and Goldman Sachs. Voltalia will use the financial proceeds to pre-finance construction work on new renewable power plants
- Our Next Energy Inc. (ONE) closed a \$300 million Series B round led by Fifth Wall and Franklin Templeton. The transaction was supported by ONE's Series A investors and new growth equity investors including Temasek, Riverstone Holdings and Coatue. Two undisclosed strategic investors including a manufacturer of EV technology solutions and a renewable energy provider also participated in the round
- Zenobe reached the financial close and started construction of the first 200MW phase of a 300MW BESS facility in Scotland, UK. The company secured a \$283 million long-term loan structured by Natwest with financing provided by Canadian Imperial Bank of Commerce, Rabobank, Santander UK and Siemens Financial Services
- Iberdrola secured \$161 million in financing from the European Investment Bank to build 400MW of wind and solar PV projects in Italy
- R.Power secured \$160 million in financing from the Three Seas Initiative Investment Fund. The investment will support R.Power's plan to achieve 1GWp of operating solar portfolio within the next 2 years across the EU markets
